

John A. Golden '66 Endowed Fellowship 2008 Information Sheet

The John A. Golden '66 Endowed Fellowship provides highly qualified students interested in pursuing a graduate law degree and a career in law with summer internship funding. Two or more Golden Fellows will be selected each year based on academic and extra curricular achievement. Fellows will receive funding to complete a summer internship in the field of law for the summer following their junior year.

Golden Fellows Application Process:

Colgate University students can apply for the fellowship if they meet the following criteria:

- Will be a rising senior during the summer of the internship;
- The recipient will have a 3.5 or greater GPA;
- The recipient will have campus leadership involvement and a demonstrated interest in pursuing a graduate degree and career in law.
- The student is in the process of applying for internship(s) or having already obtained an internship.

Application Timeline for Summer 2008:

- applications available, Monday, December 3, 2007
- application deadline, Monday, March 3, 2008 by 4 pm
- decision and notification on Friday, March 14, 2008

Application requirements include:

- A completed application.
- A two page, double-spaced proposal describing “your anticipated/obtained internship experience, intended learning objectives for the internship, and how this internship fits within your established career goals.”
- Résumé or Curriculum Vitae.
- Copy of college transcript (s), unofficial is fine.
- List of two campus references, at least one must be a faculty member.
- Position description(s) for each internship experience.
- Estimated budget for summer internship experience, which can include housing, transportation, food, or estimated summer earning to cover Fall 2008 expenses, excluding tuition.

Fellowship Recipients will keep a weekly journal, develop a portfolio of work product, conduct and document informational interviews, write a mid-internship and final report, and make a presentation about their experience.
